Study Plan Guidelines

for students of the MSc in Economics and Development March 2025

Between March 26 and April 21, 2025, as a student of the MSc in Economics and Development you should submit a study plan if you have not done so yet, or if you want to modify the most recent study plan you have previously submitted.¹ In your study plan you will specify the elective courses you will take – please find here (in Section 9) some related information.

Study plan submitted through Servizi Online You can (and should) use Servizi Online to submit your study plan if in a.y. 2023-24 or 2024-25 you enrolled for the first time in the MSc in Economics and Development. This page provides instructions concerning the on-line procedure, including a pdf guide (called submission guide) and a video tutorial, in Italian. Please contact the person in charge of study plans² if you need assistance.³

Study plan submitted in paper form You need to submit a study plan in <u>paper form</u> if you enrolled for the first time in the MSc in Economics and Development in a.y. 2022-23 or earlier, or if in the past you have submitted a study plan in paper form, or if you want to insert a PEP course in your study plan (please find <u>here</u> information on PEP courses).

- Please download the form from this page: go to the line Economics and Development (LM) and click on – say – 2022 if you enrolled for the first time in the MSc in Economics and Development in a.y. 2022-23.
- Fill in the form following the instructions <u>here</u> for the curriculum in Development Economics, <u>here</u> for the curriculum in Economics, <u>here</u> for the track in Behavioural Economics. Please pay attention to fill in <u>every field</u>; the ECTS must add up to at least 120. Most of the "codici" you need can be found <u>here</u> or <u>here</u>. ⁴
- Send by email the form to the person in charge of study plans (see footnote 2), who will check it and contact you in case some amendments are needed.
